

EXPONENTIALLY STABLE STATIONARY SOLUTIONS FOR STOCHASTIC EVOLUTION EQUATIONS AND THEIR PERTURBATION

ABSTRACT. We consider the exponential stability of stochastic evolution equations with Lipschitz continuous non-linearities when zero is not a solution for these equations. We prove the existence of a non-trivial stationary solution which is exponentially stable, where the stationary solution is generated by the composition of a random variable and the Wiener shift. We also construct stationary solutions with the stronger property of attracting bounded sets uniformly. The existence of these stationary solutions follows from the theory of random dynamical systems and their attractors. In addition, we prove some perturbation results and formulate conditions for the existence of stationary solutions for semi-linear stochastic partial differential equations with Lipschitz continuous non-linearities.

1. INTRODUCTION

The exponential stability of stochastic partial differential equations is an important problem, and it has received considerable attention during the recent decades as the vast literature on this topic shows. Our aim here is to study the exponential stability of non-trivial stationary solutions of these equations.

The investigation of stability for constant stationary solutions for finite dimensional stochastic differential equations goes back to Has'minskiĭ [14] using Lyapunov functions for the generator of the Markov semi-group. These ideas have been extended by Mao [20] in the finite dimensional context, while non-constant stationary solutions have been treated in Schmalfuß [24]. Here we will generalize some techniques from these last two publications.

For infinite dimensional (parabolic) stochastic differential equations the problem of exponentially stable constant stationary solutions has been considered by Caraballo and Real [5] (see also [3], [4]), Liu and Mao [19], Chow [7], Haussmann [15] and Ichikawa [16] among others.

In contrast to these constant stationary solutions we will investigate the asymptotic exponential stability of non-trivial stationary solutions. In this respect, we will consider semilinear stochastic evolution equations with Lipschitz continuous non-linearities. Under suitable assumptions we prove the existence of a unique stationary solution by using a fixed point argument based on the pullback technique. This stationary solution turns to be exponentially stable in mean square, and also

in the almost sure sense.

Although we prove almost sure convergence to the stationary solution, the exceptional sets depend on the initial condition, so it is not possible to consider uniform convergence with respect to a bounded set of initial conditions. However, this problem will be overcome by using a technique from random dynamical systems which allows us to study the problem for exceptional sets independent of the set of initial conditions. It is unknown in general if stochastic partial differential equations with general diffusion coefficients generate random dynamical systems. However, if we suppose some kind of commutativity on these coefficients, then we are able to prove the existence of such a random dynamical system.

We prove the existence of a random fixed point, which is in fact a random variable. This random variable generates the exponentially stable stationary solution of the stochastic partial differential equation. Moreover, this stationary solution attracts bounded sets of initial conditions.

Stationary solutions in this interpretation correspond with single point random attractors, an important object in the theory of random dynamical systems, see Crauel, Debussche and Flandoli [8], Flandoli and Schmalfuß [12] or [23].

Another aim of this paper is to analyze perturbations of stochastic partial differential equations and the relation between their stationary solutions. These perturbations will be given by modifying the non-linear part of the equation. Under the assumption that the perturbations approach the non-linear part of the original equation and that the Lipschitz constants of the perturbed operators are uniformly bounded and not too large, we obtain the existence of stationary solutions which converge to the stationary solution of our original problem in the mean square sense.

For omega-wise convergence we formulate a theorem on the continuous dependence of random fixed points on a parameter.

The paper is organized as follows. In Section 2 we introduce basic concepts of stochastic evolution equations and random dynamical systems. The third section deals with the exponential stability of stationary solutions of stochastic evolution equations in the mean square sense and almost surely. In the next section, this exponential stability is analyzed from the point of view of random dynamical systems. Then in Section 5, we consider the perturbation problems, and illustrate the results with an example in the final section.

2. RANDOM DYNAMICAL SYSTEMS AND STOCHASTIC EVOLUTION EQUATIONS

In this section we will describe the concept of exponentially stable stationary solutions for stochastic non-linear evolution equations generated by random fixed points. To do this we start by describing the noise driving the differential equation. Let $(\Omega, \mathcal{F}, \{\mathcal{F}_t\}_{t \in \mathbb{R}}, \mathbb{P})$ be a filtered probability space such that

$$\mathcal{F}_s \subset \mathcal{F}_t \subset \mathcal{F} \quad \text{for } s \leq t.$$

In what follows we will consider a two-sided Wiener process W with values in some separable Hilbert space U where the covariance Q is a symmetric operator on U of trace class. For instance, for the above probability space we will choose for Ω the

set of continuous paths $C_0(\mathbb{R}, U)$ which are zero at zero equipped with the compact open topology. \mathcal{F} is supposed to be the associated Borel- σ -algebra and \mathbb{P} is defined to be the Wiener measure with respect to the covariance Q . For \mathcal{F}_t we set

$$\sigma\{\omega(u) - \omega(v) : v, u \leq t\}.$$

What we have introduced is the *Brownian motion* metric dynamical system which is the standard noise for random dynamical systems generated by stochastic differential equations.

Note that the above probability space is not completed. The completion of this probability space is denoted by $(\Omega, \bar{\mathcal{F}}, \{\bar{\mathcal{F}}_t\}_{t \in \mathbb{R}}, \mathbb{P})$ where $\{\bar{\mathcal{F}}_t\}_{t \in \mathbb{R}}$ has to be a *normal* filtration, see Da Prato and Zabczyk [10] Page 75.

We now introduce on the above non-completed probability space a measurable flow $\theta = \{\theta_t\}_{t \in \mathbb{R}}$ on Ω :

$$(1) \quad \theta : (\mathbb{R} \times \Omega, \mathcal{F} \otimes \mathcal{B}(\mathbb{R})) \rightarrow (\Omega, \mathcal{F}), \quad \theta_{t+\tau} = \theta_t \circ \theta_\tau, \quad t, \tau \in \mathbb{R}, \quad \theta_0 = \text{id}_\Omega.$$

The *Wiener shift* operators which form the flow θ

$$\theta_t \omega(\cdot) = \omega(\cdot + t) - \omega(t), \quad t \in \mathbb{R}, \quad \omega \in \Omega$$

leave the Wiener measure \mathbb{P} invariant. More precisely, \mathbb{P} is ergodic with respect to θ . In addition, with respect to the filtration we have that

$$(2) \quad \theta_u^{-1} \mathcal{F}_t = \mathcal{F}_{t+u}$$

for any $t, u \in \mathbb{R}$, see Arnold [1] Page 72.

Since the above probability space is canonical we have for a Wiener process and its shift operator

$$W(t, \omega) = \omega(t), \quad W(t, \theta_s \omega) = \omega(t+s) - \omega(s) = W(t+s, \omega) - W(s, \omega).$$

It is important to note that the measurability in (1) is not true if we replace \mathcal{F} by its completion, see Arnold [1] Appendix A3. However, for fixed t we have the measurability of

$$\theta_t : (\Omega, \bar{\mathcal{F}}) \rightarrow (\Omega, \bar{\mathcal{F}}).$$

Moreover, the mapping $\mathbb{R} \ni t \rightarrow \theta_t \omega \in C(\mathbb{R}, U)$ is continuous for a fixed $\omega \in \Omega$.

We will study the qualitative behaviour of stochastic evolution equations on some separable Hilbert space H which have the form

$$(3) \quad dX = AXdt + f(X)dt + B(X)dW, \quad X(0) = u_0,$$

where W is the Wiener process on the probability space $(\Omega, \bar{\mathcal{F}}, \{\bar{\mathcal{F}}_t\}_{t \in \mathbb{R}}, \mathbb{P})$ introduced above. Assume that there exists a Gelfand triplet $V \subset H \subset V'$ of separable Hilbert spaces, where V' denotes the dual of V (see Temam [25] Page 55 for more details). We denote by $\|\cdot\|$, $\|\cdot\|_V$ the norms in H and V respectively. The inner product in H will be denoted by (\cdot, \cdot) , and the duality mapping between V' and V by $\langle \cdot, \cdot \rangle$. The random variable u_0 is supposed to be $(\bar{\mathcal{F}}_0, \mathcal{B}(H))$ measurable. Let us denote by $a_1 > 0$ the constant of the injection $V \subset H$, i.e.

$$a_1 \|u\|^2 \leq \|u\|_V^2, \quad \text{for } v \in V,$$

and let $-A : V \rightarrow V'$ be a positive, linear and continuous operator for which there exists a $a_2 < 0$ such that

$$\langle -Au, u \rangle \geq -a_2 \|u\|_V^2, \quad \text{for all } u \in V.$$

Then, it is well known (see, for instance, Dautray and Lions [9]) that A is the generator of a strongly continuous semigroup $\{S(t)\}_{t \geq 0}$ in H satisfying that

$$(4) \quad \|S(t)\|_{\mathcal{L}(H)} \leq e^{at},$$

where $a = a_1 a_2 < 0$.

The operator f is supposed to be Lipschitz continuous from H to H :

$$\|f(u_1) - f(u_2)\| \leq L_f \|u_1 - u_2\|, \quad u_1, u_2 \in H,$$

and B is supposed to be Lipschitz continuous with respect to the Hilbert-Schmidt norm $\mathcal{L}_2^Q(U, H)$ of linear operators from U to H :

$$\text{tr}_H((B(u_1) - B(u_2))Q(B(u_1) - B(u_2))^*) =: \|B(u_1) - B(u_2)\|_{\mathcal{L}_2^Q}^2 \leq L_B \|u_1 - u_2\|^2$$

for $u_1, u_2 \in H$.

We now need the spaces $L_{2,s} := L_2(\Omega, \bar{\mathcal{F}}_s, \mathbb{P}; H)$, $s \in \mathbb{R}$. We have the following theorem about the existence, uniqueness and regularity of (3).

Theorem 2.1. *Suppose that $u_0 \in L_{2,0}$. Then (3) has a unique (up to equivalence) mild solution $X(\cdot)$ on $[0, \infty)$ which has a continuous version. In addition,*

$$\mathbb{E} \int_0^T \|X(t)\|_V^2 dt < \infty,$$

and

$$\mathbb{E} \sup_{t \in [0, T]} \|X(t)\|^2 < \infty,$$

for any $T \geq 0$.

For the existence of a mild solution see Da Prato and Zabczyk [10] Theorem 7.4. The regularity assertion can be found in Krylov and Rozovskii [17] Chapter 2.

We are interested in stationary solutions that are exponentially attracting in the L_2 sense or almost surely. Stationary solution means that the finite dimensional distributions of the solution X are independent of shifts with respect to t . These exponentially stable stationary solutions will be generated by exponentially attracting fixed points given by an $(\bar{\mathcal{F}}_0, \mathcal{B}(H))$ -measurable random variable X^* with values in H such that if we choose the initial condition $u_0(\omega) = X^*(\omega)$ we have $X(t, \omega) = X^*(\theta_t \omega)$ almost surely for all $t \geq 0$, where the exceptional set may depend on t . This fixed point is said to be exponentially attracting if the process $(t, \omega) \rightarrow X^*(\theta_t \omega)$ (or a version of this process) attracts the solution of (3) for any (appropriate) initial condition exponentially fast in the L_2 -sense or almost surely. By the θ_t invariance of \mathbb{P} we have that

$$\begin{aligned} & \mathbb{P}(X^*(\theta_{t_1} \omega) \in B_1, \dots, X^*(\theta_{t_n} \omega) \in B_n) \\ &= \mathbb{P}(X^*(\theta_{t_1+t} \omega) \in B_1, \dots, X^*(\theta_{t_n+t} \omega) \in B_n) \end{aligned}$$

for $t \geq 0$, $0 \leq t_1 < t_2 < \dots, t_n$ and $B_1, \dots, B_n \in \mathcal{B}(H)$.

Another tool that can be used to describe the stability behaviour of a stochastic evolution equation are *random dynamical systems*. A comprehensive presentation can be found in Arnold [1]. A random dynamical system is given by a measurable mapping

$$\phi : (\mathbb{R}^+ \times \Omega \times H, \mathcal{B}(\mathbb{R}^+) \otimes \mathcal{F} \otimes \mathcal{B}(H)) \rightarrow (H, \mathcal{B}(H)),$$

satisfying the cocycle property:

$$(5) \quad \begin{aligned} \phi(t + \tau, \omega, x) &= \phi(t, \theta_\tau \omega, \phi(\tau, \omega, x)), \quad t, \tau \in \mathbb{R}^+, \omega \in \Omega, x \in H, \\ \phi(0, \omega, x) &= x, \end{aligned}$$

where θ is the flow of shift operators (Wiener shift) introduced above. We emphasize that (5) has to be satisfied for any $\omega \in \Omega$. However it is sufficient to replace Ω by a $\{\theta_t\}_{t \in \mathbb{R}}$ -invariant set of full measure. Outside of this invariant set we can redefine ϕ by the identity mapping on H . Later on we will replace Ω by a smaller $\{\theta_t\}_{t \in \mathbb{R}}$ -invariant set $\Omega' \in \mathcal{F}$. The measurability of (1) remains true if we replace \mathcal{F} by its trace σ -algebra.

The mapping ϕ is related to the solution of a stochastic or random differential equation. For the following we will always suppose that the mapping

$$H \ni x \mapsto \phi(t, \omega, x) \in H$$

is continuous for any t, ω .

Although it is known that finite dimensional stochastic differential equations generate random dynamical systems (see Arnold [1] Chapter 1), this is not true in general for infinite dimensional equations. However, for particular kinds of noise we can apply the following simple lemma to obtain a random dynamical system.

Lemma 2.2. *Let ϕ be a random dynamical system. Suppose that the mapping $T : \Omega \times H \rightarrow H$ has the following properties: For fixed $\omega \in \Omega$ the mapping $T(\omega, \cdot)$ is a homeomorphism on H . For fixed $x \in H$ the mappings $T(\cdot, x), T^{-1}(\cdot, x)$ are measurable. Then the mapping*

$$(6) \quad (t, \omega, x) \rightarrow T^{-1}(\theta_t \omega, \phi(t, \omega, T(\omega, x))) =: \psi(t, \omega, x)$$

satisfies (5). Hence ψ is a random dynamical system.

The measurability of ψ follows because of the properties of T . Later on we will transform a stochastic evolution equation containing a noise term into an evolution equation without noise but with random coefficients.

A random variable Y on $(\Omega, \mathcal{F}, \mathbb{P})$ with values in H is called *tempered* if

$$(7) \quad \lim_{t \rightarrow \pm\infty} \frac{\log^+ \|Y(\theta_t \omega)\|}{|t|} = 0,$$

or equivalently if $t \rightarrow \|Y(\theta_t \omega)\|$ has a sub-exponential growth for $t \rightarrow \pm\infty$, in other words, for $\varepsilon > 0$ and $\omega \in \Omega$ there exists a $t_0(\varepsilon, \omega) \geq 0$ such that for $|t| \geq t_0(\varepsilon, \omega)$ it holds

$$(8) \quad \|Y(\theta_t \omega)\| \leq e^{\varepsilon|t|},$$

which means that the exponential growth rate of $t \rightarrow \|Y(\theta_t \omega)\|$ is zero.

Let $\omega \rightarrow G(\omega)$ be a set valued mapping from Ω into the space of non-empty closed subsets from H . Such a mapping is called a *random set* if for any $y \in H$ the mapping

$$\omega \rightarrow \inf_{x \in G(\omega)} \|x - y\|$$

is a random variable. If G is a random set then there exists a random variable g with $g(\omega) \in G(\omega)$ (see Castaing and Valadier [6] Chapter 3). A random set G is called *tempered* if the random variable

$$\omega \rightarrow \sup_{x \in G(\omega)} \|x\|$$

is tempered. It is easily seen that the set of ω for which (7), (8) are satisfied is $\{\theta_t\}_{t \in \mathbb{T}}$ -invariant.

An $(\mathcal{F}, \mathcal{B}(H))$ -measurable random variable X^* is called a *random fixed point in the sense of random dynamical systems* if

$$\phi(t, \omega, X^*(\omega)) = X^*(\theta_t \omega)$$

for $t > 0$, where ω is contained in a $\{\theta_t\}_{t \in \mathbb{T}}$ -invariant set of full measure. X^* is an exponentially stable random fixed point with respect to a closed random set G containing X^* if for any random variable $g \in G$ we have

$$\lim_{t \rightarrow \infty} \|\phi(t, \omega, g(\omega)) - X^*(\theta_t \omega)\| = 0$$

for all ω in the above $\{\theta_t\}_{t \in \mathbb{T}}$ -invariant set of full measure with exponential speed, such that the exceptional set is independent of t . If ϕ is defined by the solution mapping of a stochastic/random differential equation then $(t, \omega) \mapsto X^*(\theta_t \omega)$ is a *stationary* solution of a stochastic/random differential equation.

Our strategy will be to prove that, under certain assumptions, a random dynamical system possesses a *random attractor* which is a single (random) point. The following definition can be found in Flandoli and Schmalfuß [12].

Definition 2.3. *Let \mathcal{D} be the set of all closed tempered random sets in H . A compact random set $\mathcal{A} \in \mathcal{D}$ is called a random attractor if the invariance property*

$$(9) \quad \phi(t, \omega, \mathcal{A}(\omega)) = \mathcal{A}(\theta_t \omega)$$

is satisfied for $\omega \in \Omega$, $t \geq 0$ and if, in addition, the pullback convergence

$$(10) \quad \lim_{t \rightarrow \infty} \text{dist}_H(\phi(t, \theta_{-t} \omega, D(\theta_{-t} \omega), \mathcal{A}(\omega))) = 0$$

holds for $D \in \mathcal{D}$ and $\omega \in \Omega$.

We note that from this convergence it follows

$$(l.i.p.) \lim_{t \rightarrow \infty} \text{dist}_H(\phi(t, \omega, D(\omega), \mathcal{A}(\theta_t \omega))) = 0,$$

where by *(l.i.p.)* we denote limit in probability. However, in general it does not imply ω wise almost sure convergence. Sufficient conditions for the existence of a random attractor can be found in [12].

Theorem 2.4. *Suppose that the mapping $x \rightarrow \phi(t, \omega, x)$ is continuous for $t \geq 0$, and completely continuous for $t > 0$ (which means that the image of every bounded*

set by the mapping $x \rightarrow \phi(t, \omega, x)$ is relatively compact). In addition, suppose there is a $G \in \mathcal{D}$ such that for any $D \in \mathcal{D}$ and $\omega \in \Omega$ there exists $T(D, \omega) > 0$ such that

$$(11) \quad \phi(t, \theta_{-t}\omega, D(\theta_{-t}\omega)) \subset G(\omega), \quad \text{for all } t \geq T(D, \omega).$$

Then there exists a unique random attractor \mathcal{A} (in \mathcal{D}).

If the random attractor $\mathcal{A}(\omega)$, $\omega \in \Omega$, consists of a single point then \mathcal{A} defines a random fixed point which attracts tempered random sets.

3. EXPONENTIAL STABILITY STOCHASTIC EVOLUTION EQUATIONS

In this section we will prove the existence of exponentially stable (both in the mean square sense and almost surely) non-trivial stationary solutions to our stochastic semi-linear partial differential equation (3). The exponential stability of trivial stationary solutions (in particular, the null solution) of stochastic PDEs has been extensively analyzed (see, for instance, [4], [19], [16],... and the literature cited therein). However, when zero is not a solution to the equation, it is interesting to find out whether or not there exist other stationary solutions, which are generated by random variables chosen as initial values in our problem, and to analyze their stability properties. This fact, can also be considered as a connection between the classical method for the local analysis of the long-time behaviour of stochastic partial differential equations and the global one provided by the theory of random dynamical systems.

In the sequel we consider the process $\theta_s W(\cdot, \omega) = W(\cdot, \theta_s \omega) = W(\cdot + s, \omega) - W(s, \omega)$, for $s \in \mathbb{R}$, which is also a Wiener process with covariance Q . For $t \geq 0$ this process is adapted to the filtration $\{\mathcal{F}_{s+t}\}_{t \geq 0}$ which follows from (2). We will denote by $\Phi(\cdot, s, u_0)$ the solution of (3), corresponding to the initial value $u_0 \in L_{2,s}$, which is driven by $\theta_s W$, and satisfying the assertions of Theorem 2.1.

The following equality holds for $u_0 \in L_{2,0}$:

$$(12) \quad \Phi(\cdot, 0, u_0)(\theta_s \cdot) = \Phi(\cdot, s, u_s)(\cdot), \quad \text{almost surely,}$$

where $u_s(\cdot) := u_0(\theta_s \cdot)$. Both sides of (12) are driven by the same Wiener process and the same initial condition and the fact that solutions of (3) are unique. Indeed, by (2) $u_0(\theta_s \cdot)$ is \mathcal{F}_s -measurable.

Lemma 3.1. *i) For $s \in \mathbb{R}$, $\tau \geq 0$, $u_0 \in L_{2,s}$*

$$\Phi(\cdot, s + \tau, \Phi(\tau, s, u_0)) = \Phi(\cdot + \tau, s, u_0), \quad \text{almost surely.}$$

ii) Set

$$(13) \quad \mu := 2a + 2L_f + L_B.$$

Then

$$\mathbb{E} \|\Phi(t, s, u_0^1) - \Phi(t, s, u_0^2)\|^2 \leq e^{\mu t} \mathbb{E} \|u_0^1 - u_0^2\|^2$$

for $t \geq 0$, $s \in \mathbb{R}$, $u_0^1, u_0^2 \in L_{2,s}$.

Proof. i) Consider the process

$$Y(r, \omega) = \begin{cases} \Phi(r, s, u_0)(\omega) & : 0 \leq r \leq \tau \\ \Phi(r - \tau, s + \tau, \Phi(\tau, s, u_0))(\omega) & : r > \tau \end{cases},$$

which is continuous (almost surely) by the continuity of Φ . For $r > \tau$ we have

$$\begin{aligned}
Y(r) &= S(r - \tau)\Phi(\tau, s, u_0) \\
&+ \int_0^{r-\tau} S(r - \tau - q)f(\Phi(q, s + \tau, \Phi(\tau, s, u_0)))dq \\
&+ \int_0^{r-\tau} S(r - \tau - q)B(\Phi(q, s + \tau, \Phi(\tau, s, u_0)))d(W(q + s + \tau) - W(s + \tau)) \\
&= S(r)u_0 \\
&+ \int_\tau^r S(r - q)f(Y(q))dq + S(r - \tau) \int_0^\tau S(\tau - q)f(Y(q))dq \\
&+ \int_\tau^r S(r - q)B(Y(q))d(W(q + s) - W(s)) \\
&+ S(r - \tau) \int_0^\tau S(\tau - q)B(Y(q))d(W(q + s) - W(s)).
\end{aligned}$$

The first conclusion follows if we concatenate the integrals and use the fact that for the increments of the Wiener process we have

$$\begin{aligned}
&W(q_1 + s + \tau) - W(s + \tau) - (W(q_2 + s + \tau) - W(s + \tau)) \\
&= W(q_1 + s + \tau) - W(s) - (W(q_2 + s + \tau) - W(s)).
\end{aligned}$$

ii) It is not hard to see by the properties of the coefficients that (3) has the trajectories in $L_2(0, T; V)$ (see Krylov and Rozovskii [17], or Grecksch and Tudor [13]) which allows us to apply the Ito formula for the process $e^{-\mu t}\|X_1(t) - X_2(t)\|^2$ where we have denoted $X_i(t) := \Phi(t, s, u_0^i)$, $i = 1, 2$. Thus

$$\begin{aligned}
(14) \quad &e^{-\mu t}\|X_1(t) - X_2(t)\|^2 \\
&= \|u_0^1 - u_0^2\|^2 - \mu \int_0^t e^{-\mu q}\|X_1(q) - X_2(q)\|^2 dq \\
&+ 2 \int_0^t e^{-\mu q} \langle A(X_1(q) - X_2(q)), X_1(q) - X_2(q) \rangle dq \\
&+ 2 \int_0^t e^{-\mu q} (f(X_1(q)) - f(X_2(q)), X_1(q) - X_2(q)) dq \\
&+ \int_0^t e^{-\mu q} \|B(X_1(q)) - B(X_2(q))\|_{\mathcal{L}_2^2}^2 dq \\
&+ 2 \int_0^t e^{-\mu q} (X_1(q) - X_2(q), (B(X_1(q)) - B(X_2(q)))) dW(q, \theta_s \omega) \\
&\leq \|u_0^1 - u_0^2\|^2 + \int_0^t e^{-\mu q} (-\mu + 2a + 2L_f + L_B) \|X_1(q) - X_2(q)\|^2 dq \\
&+ 2 \int_0^t e^{-\mu q} (X_1(q) - X_2(q), (B(X_1(q)) - B(X_2(q)))) dW(q, \theta_s \omega). \\
&\leq \|u_0^1 - u_0^2\|^2 + 2 \int_0^t e^{-\mu q} (X_1(q) - X_2(q), (B(X_1(q)) - B(X_2(q)))) dW(q, \theta_s \omega).
\end{aligned}$$

The result follows easily by calculating the expectation if we replace t by $t \wedge T_N$, where T_N is a family of stopping times

$$T_N(\omega) = \inf\{t \geq 0 : \|X_1(t, \omega)\|^2 + \|X_2(t, \omega)\|^2 \geq N\}$$

such that

$$\lim_{N \rightarrow \infty} (T_N \wedge t) = t, \quad \text{almost surely,}$$

since X_1, X_2 have continuous paths. \square

Corollary 3.2. $\Phi(t, s, \cdot)$ maps $L_{2,s}$ into $L_{2,s+t}$ continuously.

We shall now show the existence of an exponentially stable solution for (3).

Theorem 3.3. *Suppose that the constant μ appearing in (13) is negative. Then there exists an exponentially attracting fixed point $X^* \in L_{2,0}$ generating an exponentially stable stationary solution for (3). In particular, the process $(t, \omega) \rightarrow X^*(\theta_t \omega)$ has a continuous version given by $\Phi(\cdot, 0, X^*)$.*

Proof. We show that $(\Phi(k, -k, u_0(\theta_{-k} \cdot)))_{k \in \mathbb{N}}$ is a Cauchy sequence in $L_{2,0}$ for $u_0 \in L_{2,0}$. Notice that for this u_0 we have that $u_0(\theta_{-k} \cdot) \in L_{2,-k}$. Indeed,

$$\begin{aligned} & \mathbb{E} \|\Phi(k, -k, u_0(\theta_{-k} \cdot)) - \Phi(k-1, 1-k, u_0(\theta_{1-k} \cdot))\|^2 \\ &= \mathbb{E} \|\Phi(k-1, 1-k, \Phi(1, -k, u_0(\theta_{-k} \cdot))) - \Phi(k-1, 1-k, u_0(\theta_{1-k} \cdot))\|^2 \\ &\leq e^{\mu(k-1)} \mathbb{E} \|\Phi(1, -k, u_0(\theta_{-k} \cdot)) - u_0(\theta_{1-k} \cdot)\|^2 \\ &= e^{\mu(k-1)} \mathbb{E} \|\Phi(1, 0, u_0(\cdot)) - u_0(\theta_1 \cdot)\|^2 \end{aligned}$$

Here we have applied Lemma 3.1 i), the $\{\theta_t\}_{t \in \mathbb{R}}$ -invariance of \mathbb{P} and (12). The Cauchy sequence property follows since $\mu < 0$. Let the limit of this sequence be denoted by $X^* \in L_{2,0}$.

X^* as an element in $L_{2,0}$ is independent of the choice of $u_0 \in L_{2,0}$. Indeed, for $v_0 \in L_{2,0}$ we have that

$$\begin{aligned} & \mathbb{E} \|\Phi(k, -k, u_0(\theta_{-k} \cdot)) - \Phi(k, -k, v_0(\theta_{-k} \cdot))\|^2 \\ &= \mathbb{E} \|\Phi(k, 0, u_0(\cdot)) - \Phi(k, 0, v_0(\cdot))\|^2 \leq e^{\mu k} \mathbb{E} \|u_0 - v_0\|^2, \end{aligned}$$

which goes to zero for $k \rightarrow \infty$ such that the limit of the above Cauchy sequence in $L_{2,0}$ is independent of u_0 . Since $X^* \in L_{2,0}$ the process $\Phi(\cdot, 0, X^*)$ satisfies all of the conclusions of Theorem 2.1. We now show that

$$\Phi(t, 0, X^*)(\cdot) = X^*(\theta_t \cdot) \quad \text{almost surely for any } t \in \mathbb{R}^+.$$

By the definition of $X^*(\omega)$ the random variable $X^*(\theta_t \cdot)$ is given by

$$(L_2) \lim_{k \rightarrow \infty} \Phi(k, -k, u_0(\theta_{-k} \cdot))(\theta_t \omega)$$

which is equal to

$$(L_2) \lim_{k \rightarrow \infty} \Phi(k, t-k, u_0(\theta_{t-k} \cdot))(\omega)$$

by (12). On account of Corollary 3.2 and Lemma 3.1 we have

$$\begin{aligned}
& \mathbb{E}\|\Phi(t,0, X^*) - X^*(\theta_{t\cdot})\|^2 \\
&= \mathbb{E}\|\Phi(t,0, (L_2) \lim_{k \rightarrow \infty} \Phi(k, -k, u_0(\theta_{-k\cdot})) - (L_2) \lim_{k \rightarrow \infty} \Phi(k, t-k, u_0(\theta_{t-k\cdot}))\|^2 \\
&= \lim_{k \rightarrow \infty} \mathbb{E}\|\Phi(t,0, \Phi(k, -k, u_0(\theta_{-k\cdot})) - \Phi(k, t-k, u_0(\theta_{t-k\cdot}))\|^2 \\
&= \lim_{k \rightarrow \infty} \mathbb{E}\|\Phi(k, t-k, \Phi(t, -k, u_0(\theta_{-k\cdot})) - \Phi(k, t-k, u_0(\theta_{t-k\cdot}))\|^2 \\
&\leq \lim_{k \rightarrow \infty} e^{\mu k} \mathbb{E}\|\Phi(t, -k, u_0(\theta_{-k\cdot})) - u_0(\theta_{t-k\cdot})\|^2 \\
&= \lim_{k \rightarrow \infty} e^{\mu k} \mathbb{E}\|\Phi(t,0, u_0) - u_0(\theta_{t\cdot})\|^2 = 0,
\end{aligned}$$

since $\mu < 0$ and t is fixed. \square

Remark 3.4. *It follows from the second part of Lemma 3.1 that $\Phi(t,0, u_0) - \Phi(t,0, X^*)$ tends to zero exponentially fast in $L_2(\Omega, \mathcal{F}, \mathbb{P})$ for $t \rightarrow \infty$.*

In contrast to the L_2 -convergence to the stationary solution we now show that

$$\lim_{t \rightarrow \infty} \|\Phi(t,0, u_0) - \Phi(t,0, X^*)\|^2 = 0, \quad \text{almost surely,}$$

for an $(\bar{\mathcal{F}}_0, \mathcal{B}(H))$ random variable u_0 and X^* is given by the random fixed point of (3).

Theorem 3.5. *Assume $\mu < 0$. For a random variable $u_0 \in L_{2,0}$ we have that*

$$\lim_{t \rightarrow \infty} \|\Phi(t,0, u_0) - \Phi(t,0, X^*)\| = 0$$

almost surely exponentially fast.

Proof. Take an $(\bar{\mathcal{F}}_0, \mathcal{B}(H))$ -measurable random variable $u_0 \in L_{2,0}$ and let us denote

$$\Phi(t,0, u_0) = X_1(t), \quad \Phi(t,0, X^*) = X_2(t).$$

Recall that from Lemma 3.1 it holds that

$$(15) \quad \mathbb{E}\|X_1(t) - X_2(t)\|^2 \leq e^{\mu t} \mathbb{E}\|u_0 - X^*\|^2 \quad \text{for all } t \geq 0 \quad (\mu < 0).$$

We will first prove that there exists a positive constant C such that

$$(16) \quad \mathbb{E} \sup_{t \in [N, N+1]} \|X_1(t) - X_2(t)\|^2 \leq C e^{\mu N} \mathbb{E}\|u_0 - X^*\|^2$$

for any $N \in \mathbb{N}$. Similarly to (14) we obtain for $t \geq N$

$$(17) \quad \mathbb{E}\|X_1(t) - X_2(t)\|^2 = \mathbb{E}\|X_1(N) - X_2(N)\|^2 e^{\mu(t-N)} \leq \mathbb{E}\|u_0 - X^*\|^2 e^{\mu t}.$$

Using Ito's formula for $\|X_1(t) - X_2(t)\|^2$ (see [17]) and taking into account that μ defined in (13) is negative, we find

$$\begin{aligned}
(18) \quad & \mathbb{E} \sup_{t \in [N, N+1]} \|X_1(t) - X_2(t)\|^2 \leq \mathbb{E}\|X_1(N) - X_2(N)\|^2 \\
& + 2\mathbb{E} \sup_{t \in [N, N+1]} \left| \int_N^t (X_1 - X_2, (B(X_1) - B(X_2))dW(s)) \right|.
\end{aligned}$$

Now we evaluate the last term in (18) by applying the Burkholder-Davis-Gundy lemma. Indeed, it follows by (17) that

$$\begin{aligned}
& 2\mathbb{E} \sup_{t \in [N, N+1]} \left| \int_N^t (X_1 - X_2, (B(X_1) - B(X_2))dW(s)) \right| \\
& \leq C_1 \mathbb{E} \left(\int_N^{N+1} \|X_1 - X_2\|^2 \|B(X_1) - B(X_2)\|_{\mathcal{L}_2^Q}^2 ds \right)^{1/2} \\
(19) \quad & \leq C_1 \mathbb{E} \left(\sup_{t \in [N, N+1]} \|X_1(t) - X_2(t)\|^2 \int_N^{N+1} \|B(X_1) - B(X_2)\|_{\mathcal{L}_2^Q}^2 ds \right)^{1/2} \\
& \leq \frac{1}{2} \mathbb{E} \sup_{t \in [N, N+1]} \|X_1(t) - X_2(t)\|^2 + \frac{C_1^2 L_B}{2} \mathbb{E} \|u_0 - X^*\|^2 \int_N^{N+1} e^{\mu s} ds \\
& \leq \frac{1}{2} \mathbb{E} \sup_{t \in [N, N+1]} \|X_1(t) - X_2(t)\|^2 + \frac{C_1^2 L_B}{2} e^{\mu N} \mathbb{E} \|u_0 - X^*\|^2.
\end{aligned}$$

Consequently, (15), (18) and (19) imply (16). The expectation of the sup-term on the right hand side just exists by Theorem 2.1. On account of the Tschebyshev inequality we have for a small $\varepsilon > 0$

$$\begin{aligned}
& \mathbb{P} \left(\sup_{t \in [N, N+1]} \|X_1(t) - X_2(t)\|^2 \geq e^{(\mu+\varepsilon)N} \right) \\
& \leq \frac{e^{-\mu N} \mathbb{E} \sup_{t \in [N, N+1]} \|X_1(t) - X_2(t)\|^2}{e^{\varepsilon N}} \leq \frac{C \mathbb{E} \|u_0 - X^*\|^2}{e^{\varepsilon N}}.
\end{aligned}$$

Note that the series $\sum_{N=1}^{\infty} e^{-\varepsilon N}$ is finite. Hence the conclusion follows by the Borel-Cantelli Lemma. \square

Remark 3.6. *If $f(0) = B(0) = 0$ then $X^* \equiv 0$.*

4. EXPONENTIAL STABILITY FOR STOCHASTIC EVOLUTION EQUATIONS GENERATING RANDOM DYNAMICAL SYSTEMS

The disadvantage of the method in the last section is that the exceptional sets for the definition of the random fixed point X^* depend explicitly on the initial condition u_0 which appears in the defining Cauchy sequence. It is rather complicated to obtain the exponential convergence to the stationary solution uniformly with respect to a bounded set of initial conditions. We will try to overcome this disadvantage in this section. For this purpose it is more appropriate to consider stochastic evolution equations in the Stratonovich form. We also suppose that the diffusion part of this equation is given by

$$B(X) \circ dW = B_1 X \circ dw_1 + \cdots + B_N X \circ dw_N,$$

where w_1, \dots, w_N are one-dimensional mutually independent standard Wiener processes and $W = (w_1, \dots, w_N)$ so that the phase space U for the Wiener process is given by \mathbb{R}^N , and $B_i \in \mathcal{L}(H)$ for $i = 1, \dots, N$. We will denote $b_i = \|B_i\|_{\mathcal{L}(H)}$. This means that we will consider the equation

$$(20) \quad dX = (AX + f(X))dt + \sum_{i=1}^N B_i X \circ dw_i.$$

As our approach in this section is based on dynamical techniques, we use here the Stratonovich interpretation of our stochastic partial differential equation. Notice that, due to the equivalence which exists between the Stratonovich and the Ito interpretation for the stochastic integral, one can formulate the corresponding results for our initial problem (3) by simply redefining in a suitable way the operators in the model.

The operators B_i generate C_0 -groups which we will denote by S_{B_i} . In addition, we suppose the operators A, B_1, \dots, B_N mutually commute, what implies that these groups and the semigroup generated by A are also mutually commuting. A has been introduced in Section 2.

For what follows, we will fix a *one-dimensional Wiener process* with $U = \mathbb{R}$ and $\mathbb{E}|w(1)|^2 = 1$. We consider the one-dimensional stochastic differential equation

$$(21) \quad dz = -\lambda z dt + dw(t)$$

for some $\lambda > 0$. This equation has a random fixed point in the sense of random dynamical systems generating a stationary solution known as the stationary Ornstein-Uhlenbeck process.

Lemma 4.1. *Let λ be a positive number and consider the probability space as in Section 2 with $U = \mathbb{R}$. There exists a $\{\theta_t\}_{t \in \mathbb{R}}$ -invariant subset $\bar{\Omega} \in \mathcal{F}$ of $\Omega = C_0(\mathbb{R}, \mathbb{R})$ of full measure such that*

$$\lim_{t \rightarrow \pm\infty} \frac{|\omega(t)|}{t} = 0 \quad \text{for } \omega \in \bar{\Omega},$$

and, for such ω , the random variable given by

$$z^*(\omega) := -\lambda \int_{-\infty}^0 e^{\lambda\tau} \omega(\tau) d\tau$$

is well defined. Moreover, for $\omega \in \bar{\Omega}$, the mapping

$$(22) \quad \begin{aligned} (t, \omega) &\rightarrow z^*(\theta_t \omega) = -\lambda \int_{-\infty}^0 e^{\lambda\tau} \theta_t \omega(\tau) d\tau \\ &= -\lambda \int_{-\infty}^0 e^{\lambda\tau} \omega(t + \tau) d\tau + \omega(t) \end{aligned}$$

is a stationary solution of (21) with continuous trajectories. In addition, for $\omega \in \bar{\Omega}$

$$(23) \quad \begin{aligned} \lim_{t \rightarrow \pm\infty} \frac{|z^*(\theta_t \omega)|}{|t|} &= 0, & \lim_{t \rightarrow \pm\infty} \frac{1}{t} \int_0^t z^*(\theta_\tau \omega) d\tau &= 0, \\ \lim_{t \rightarrow \pm\infty} \frac{1}{t} \int_0^t |z^*(\theta_\tau \omega)| d\tau &= \mathbb{E}|z^*| < \infty. \end{aligned}$$

Proof. The first statement follows from the law of iterated logarithm. It is easily seen that the process

$$(\omega, t) \rightarrow \int_{-\infty}^t e^{-\lambda(t-\tau)} dw(\tau, \omega)$$

is a solution of the differential equation (21). Starting from this fact we construct $z^*(\omega)$. By the integration by parts formula (see Øksendal, [22]) we see that (22) is

a version of this solution. Indeed, for $w = w(\cdot, \theta_{-t}\omega) = \theta_{-t}\omega(\cdot)$ we have

$$\begin{aligned} \int_0^t e^{-\lambda(t-\tau)} dw(\tau, \theta_{-t}\omega) &= e^{-\lambda \cdot 0} w(t, \theta_{-t}\omega) - e^{-\lambda t} w(0, \theta_{-t}\omega) \\ &\quad - \lambda \int_0^t e^{-\lambda(t-\tau)} (w(\tau - t, \omega) - w(-t, \omega)) d\tau \\ &= -w(-t, \omega) - \lambda \int_0^t e^{-\lambda(t-\tau)} w(t - \tau, \omega) d\tau \\ &\quad + w(-t, \omega) e^{-\lambda t} (e^{\lambda t} - 1). \end{aligned}$$

Using the integral transformation $\tau \rightarrow \tau - t$ and letting $t \rightarrow \infty$ we have that the right hand side tends to $z^*(\omega)$ for those ω satisfying the above growth condition. Now we use that $\omega(t) = w(t, \omega)$ since we have a canonical probability space.

The stationarity of this solution follows by the invariance of the Wiener measure \mathbb{P} with respect to the flow θ .

The other statements follow by the ergodic theorem and the Burkholder inequality, which allows us to conclude that $\mathbb{E} \sup_{t \in [0,1]} |z^*(\theta_t \omega)| < \infty$. Together with the ergodic theorem we then obtain the first formula in (23). Note that $\bar{\Omega} \in \mathcal{F}$. This follows from the fact that by the continuity of $t \rightarrow z^*(\theta_t \omega)$ the mapping $\omega \rightarrow \sup_{t \in [0,1]} |z^*(\theta_t \omega)|$ is an $(\mathcal{F}, \mathcal{B}(\mathbb{R}))$ -measurable mapping. \square

Remark 4.2. *We now consider θ defined in (1) on $\bar{\Omega}$ instead of Ω . This mapping has the same properties as the original one if we choose for \mathcal{F} the trace σ -algebra with respect to $\bar{\Omega}$ denoted also by \mathcal{F} .*

Let $\lambda_1, \dots, \lambda_N$ be a set of positive numbers. For any pair λ_j, w_j we have a stationary Ornstein-Uhlenbeck process generated by a random variable $z_j^*(\omega)$ on $\bar{\Omega}_j$ with properties formulated in Lemma 4.1 defined on the metric dynamical system $(\bar{\Omega}_j, \mathcal{F}_j, \mathbb{P}_j, \theta)$. We set

$$(24) \quad (\Omega, \mathcal{F}, \mathbb{P}, \theta),$$

where

$$\Omega = \bar{\Omega}_1 \times \dots \times \bar{\Omega}_N, \quad \mathcal{F} = \bigotimes_{i=1}^N \mathcal{F}_i, \quad \mathbb{P} = \mathbb{P}_1 \times \mathbb{P}_2 \times \dots \times \mathbb{P}_N,$$

and θ is the flow of Wiener shifts.

To find random fixed points for (20) we will transform this equation into an evolution equation with random coefficients but without white noise. Let

$$T(\omega) := S_{B_1}(z_1^*(\omega)) \circ \dots \circ S_{B_N}(z_N^*(\omega))$$

be a family of random linear homeomorphisms on H . The inverse operator is well defined by

$$T^{-1}(\omega) := S_{B_N}(-z_N^*(\omega)) \circ \dots \circ S_{B_1}(-z_1^*(\omega))$$

Because of the estimate

$$\|T^{-1}(\omega)\| \leq e^{\|B_1\| |z_1^*(\omega)|} \dots e^{\|B_N\| |z_N^*(\omega)|}$$

and (23), it follows that $\|T^{-1}(\theta_t \omega)\|$ has sub-exponential growth as $t \rightarrow \pm\infty$ for any $\omega \in \Omega$. Hence $\|T^{-1}\|$ is tempered. On the other hand, since z_j^* , $j = 1, \dots, N$

are independent Gaussian random variables we have that

$$\prod_{j=1}^N \mathbb{E}(\|S_{B_j}(-z_j^*)\| \|S_{B_j}(z_j^*)\|) < \infty.$$

Hence by the ergodic theorem we still have a $\{\theta_t\}_{t \in \mathbb{R}}$ -invariant set $\bar{\Omega} \in \mathcal{F}$ of full measure such that

$$(25) \quad \lim_{t \rightarrow \pm\infty} \frac{1}{t} \int_0^t \|T(\theta_\tau \omega)\| \|T^{-1}(\theta_\tau \omega)\| d\tau = \mathbb{E} \|T\| \|T^{-1}\| \\ \leq \prod_{j=1}^N \mathbb{E}(\|S_{B_j}(-z_j^*)\| \|S_{B_j}(z_j^*)\|).$$

According to Remark 4.2 we can change our metric dynamical system with respect to $\bar{\Omega}$. However the new metric dynamical system will be denoted by the old symbols $(\Omega, \mathcal{F}, \mathbb{P}, \theta)$.

We formulate an evolution equation with random coefficients but without white noise

$$(26) \quad \frac{d\psi}{dt} = \left(A + \sum_{j=1}^N \lambda_j z_j^*(\theta_t \omega) B_j \right) \psi + T^{-1}(\theta_t \omega) f(T(\theta_t \omega) \psi),$$

and initial condition $\psi(0) = x \in H$.

Lemma 4.3. *Suppose that A, B_1, \dots, B_N satisfy the preceding assumptions. Then*

- i) the random evolution equation (26) possesses a unique solution, and this solution generates a random dynamical system.*
- ii) if ψ is the random dynamical system in i),*

$$(27) \quad \phi(t, \omega, x) = T(\theta_t \omega) \psi(t, \omega, T^{-1}(\omega) x)$$

is another random dynamical system for which the process

$$(\omega, t) \rightarrow \phi(t, \omega, x)$$

solves (20) for any initial condition $x \in H$.

Proof. i) We mention only that by the continuity of $t \rightarrow T(\theta_t \omega)$ the mapping $x \rightarrow T^{-1}(\theta_t \omega) f(T(\theta_t \omega) x)$ is Lipschitz continuous, where the Lipschitz constant is uniformly bounded for $t \in [0, T]$, $T > 0$. Hence we can prove the existence and uniqueness of a mild solution of this equation for any ω . The proof of measurability is straightforward.

ii) According to the chain rule (and omitting for simplicity the arguments in the

mappings T and ψ we have

$$\begin{aligned}
d(T\psi) &= \sum_{i=1}^N B_i T\psi \circ dz_i^* + T(A + \sum_{i=1}^N \lambda_i z_i^* B_i)\psi dt + f(T\psi)dt \\
&= - \sum_{i=1}^N \lambda_i B_i z_i^* T\psi dt + \sum_{i=1}^N B_i T\psi \circ dw_i \\
&\quad + AT\psi dt + \sum_{i=1}^N \lambda_i B_i z_i^* T\psi dt + f(T\psi)dt \\
&= A\phi + \sum_{i=1}^N B_i \phi \circ dw_i + f(\phi)
\end{aligned}$$

since T commutes with A, B_i . Hence, the mapping defined by (27) is a solution of (20). On account of Lemma 2.2, ϕ and ψ are conjugated random dynamical systems. \square

Now we can formulate the first main conclusion of this section.

Theorem 4.4. *Suppose A, B_1, \dots, B_N mutually commute and $W = (w_1, \dots, w_N)$ satisfies the assumptions at the beginning of this section. In addition, suppose that*

$$(28) \quad a + \sum_{j=1}^N b_j \lambda_j \mathbb{E}|z_j^*| + L_f \prod_{j=1}^N \mathbb{E}(\|S_{B_j}(-z_j^*)\| \|S_{B_j}(z_j^*)\|) < 0.$$

Then the random dynamical system generated by (20) admits a unique exponentially stable stationary solution given by a random fixed point X^ in the sense of random dynamical systems.*

Proof. 1) Suppose that the random dynamical system ψ has the random fixed point Y^* . Then by (27)

$$X^*(\omega) = T(\omega)Y^*(\omega)$$

is a random fixed point of ϕ . If

$$\psi(t, \omega, x) - Y^*(\theta_t \omega)$$

tends to zero for $t \rightarrow \infty$ exponentially fast, then

$$\phi(t, \omega, x) - X^*(\theta_t \omega)$$

also tends to zero for $t \rightarrow \infty$ exponentially fast since the norm of the linear mapping $T(\omega)$ is tempered. Hence to prove the theorem it is sufficient to show that (26) has a unique exponentially attracting fixed point.

2) In order to obtain a random fixed point for ψ we first check the condition for Theorem 2.4.

According to the Lipschitz continuity of f we have

$$\|f(x)\| \leq L_f \|x\| + \|f(0)\|.$$

This inequality gives us the differential inequality

$$\begin{aligned}
(29) \quad \frac{d\|\psi(t)\|^2}{dt} &\leq 2(a + \sum_{j=1}^N \lambda_j b_j |z_j^*(\theta_t \omega)| + \|T(\theta_t \omega)\| \|T^{-1}(\theta_t \omega)\| L_f + \frac{\varepsilon}{2}) \|\psi(t)\|^2 \\
&\quad + \frac{1}{\varepsilon} \|T^{-1}(\theta_t \omega)\|^2 \|f(0)\|^2.
\end{aligned}$$

for a sufficiently small $\varepsilon > 0$. Comparing the coefficients of (29) we have $\|\psi(t)\|^2 \leq R^2(t)$ if $\|\psi(0)\|^2 \leq R^2(0)$ where $R^2(t)$ is the solution of

$$(30) \quad \begin{aligned} \frac{dR^2}{dt} = & 2\left(a + \sum_{j=1}^N \lambda_j b_j |z_j^*(\theta_t \omega)| + \|T(\theta_t \omega)\| \|T^{-1}(\theta_t \omega)\|_{L_f} + \frac{\varepsilon}{2}\right) R^2 \\ & + \frac{1}{\varepsilon} \|T^{-1}(\theta_t \omega)\|^2 \|f(0)\|^2. \end{aligned}$$

Under the assumptions of the theorem, this equation has the unique exponentially stable stationary solution $t \rightarrow R^2(\theta_t \omega)$ defined by the random variable

$$(31) \quad \begin{aligned} R^2(\omega) := & \int_{-\infty}^0 \frac{1}{\varepsilon} \|T^{-1}(\theta_t \omega)\|^2 \|f(0)\|^2 \times \\ & \times \exp \left(\int_t^0 2\left(a + \sum_{j=1}^N \lambda_j b_j |z_j^*(\theta_\tau \omega)| + \|T(\theta_\tau \omega)\| \|T^{-1}(\theta_\tau \omega)\|_{L_f} + \frac{\varepsilon}{2}\right) d\tau \right) dt \end{aligned}$$

for $\omega \in \Omega$, which in turn follows easily by the variation of constants formula. This random variable is tempered (and finite), see Lemma 4.6 below. In particular the ball in H given by $G(\omega) := B(0, 2R(\omega))$ is mapped into itself:

$$\psi(t, \omega, G(\omega)) \subset G(\theta_t \omega) \quad \text{for } \omega \in \Omega.$$

Indeed this ball is tempered. In addition, this ball has the property (11). To see this we consider the differential equation (30) with some random tempered initial condition $r^2(\omega)$. If we replace ω by $\theta_{-t}\omega$ for the solution of (30) at time t we have by the variation of constants formula

$$\begin{aligned} & r^2(\theta_{-t}\omega) \exp \left(\int_t^0 2\left(a + \sum_{j=1}^N \lambda_j b_j |z_j^*(\theta_\tau \omega)| + \|T(\theta_\tau \omega)\| \|T^{-1}(\theta_\tau \omega)\|_{L_f} + \frac{\varepsilon}{2}\right) d\tau \right) \\ & + \int_t^0 \frac{1}{\varepsilon} \|T^{-1}(\theta_s \omega)\|^2 \|f(0)\|^2 \times \\ & \times \exp \left(\int_s^0 2\left(a + \sum_{j=1}^N \lambda_j b_j |z_j^*(\theta_\tau \omega)| + \|T(\theta_\tau \omega)\| \|T^{-1}(\theta_\tau \omega)\|_{L_f} + \frac{\varepsilon}{2}\right) d\tau \right) ds. \end{aligned}$$

This term tends to $R^2(\omega)$ as $t \rightarrow -\infty$ which follows by Birkhoff's ergodic theorem, (23), (28), (25). In particular the first term tends to zero. From Theorem 2.4 we just obtain the existence of a random attractor $\mathcal{A} = \{\mathcal{A}(\omega)\}_{\omega \in \Omega} \subset G$.

Set

$$\Delta\psi(t, \omega, x_1, x_2) = \psi(t, \omega, x_1) - \psi(t, \omega, x_2).$$

Then we have

$$\frac{d\|\Delta\psi(t)\|^2}{dt} \leq 2\left(a + \sum_{j=1}^N \lambda_j b_j |z_j^*(\theta_t \omega)| + \|T(\theta_t \omega)\| \|T^{-1}(\theta_t \omega)\|_{L_f}\right) \|\Delta\psi(t)\|^2.$$

We can conclude by the invariance property (9)

$$(32) \quad \sup_{y_1, y_2 \in \mathcal{A}(\omega)} \|y_1 - y_2\|^2 \leq \sup_{x_1, x_2 \in \mathcal{A}(\theta_{-t}\omega)} \|x_1 - x_2\|^2 \times \\ \times \exp \left(\int_t^0 2(a + \sum_{j=1}^N \lambda_j b_j |z_j^*(\theta_\tau \omega)| + \|T(\theta_\tau \omega)\| \|T^{-1}(\theta_\tau \omega)\| L_f) d\tau \right)$$

Since $\mathcal{A} \subset G$, it is tempered, and we obtain from the properties of z_j^* and T that the right hand side tends to zero for $\omega \in \Omega$, hence $\mathcal{A}(\omega)$ is a random fixed point denoted by Y^* . To see that Y^* is exponentially attracting we note that

$$\sup_{x \in D(\omega)} \|\psi(t, \omega, x) - Y^*(\theta_t \omega)\|^2 = \sup_{x \in D(\omega)} \|\psi(t, \omega, x) - \psi(t, \omega, Y^*(\omega))\|^2 \\ \leq \sup_{x \in D(\omega)} \|x - Y^*(\omega)\|^2 \times \\ \times \exp \left(\int_0^t 2(a + \sum_{j=1}^N \lambda_j b_j |z_j^*(\theta_\tau \omega)| + \|T(\theta_\tau \omega)\| \|T^{-1}(\theta_\tau \omega)\| L_f) d\tau \right),$$

and the right hand side tends to zero exponentially fast for $\omega \in \Omega$. \square

Since we now know that $\mathcal{A}(\omega)$ is a single point we have similarly to (32) and (10) that

Corollary 4.5. *The random fixed point Y^* (hence X^*) attracts tempered random sets in the pullback sense.*

We now prove the temperedness of R^2 .

Lemma 4.6. *For $\omega \in \Omega$ the mapping $t \rightarrow R^2(\theta_t \omega)$ has subexponential growth, hence R^2 is tempered.*

Proof. We abbreviate

$$\alpha(\omega) = a + \sum_{j=1}^N \lambda_j b_j |z_j^*(\omega)| + \|T(\omega)\| \|T^{-1}(\omega)\| L_f + \frac{\varepsilon}{2}, \quad \mathbb{E}\alpha =: \bar{\alpha} < 0, \\ \beta(\omega) = \frac{1}{\varepsilon} \|T^{-1}(\omega)\|^2 \|f(0)\|^2.$$

By the definition of Ω we have

$$\int_t^0 \alpha(\theta_\tau \omega) d\tau \sim \bar{\alpha} |t| \quad \text{for } \omega \in \Omega, \quad t \rightarrow -\infty.$$

In addition $t \rightarrow \beta(\theta_t \omega)$ has sub-exponential growth for $t \rightarrow \pm\infty$ such that

$$R^2(\omega) = \int_{-\infty}^0 \exp \left(\int_t^0 \alpha(\theta_\tau \omega) \right) \beta(\theta_t \omega) dt < \infty.$$

For an arbitrary $c > 0$, $0 < \varepsilon < \min(-\bar{\alpha}, \frac{c}{2})/4$ and negative $s < s_0(\omega, \varepsilon)$ we then have

$$\begin{aligned} & e^{cs} \int_{-\infty}^0 e^{\int_t^0 \alpha(\theta_{\tau+s}\omega) d\tau} \beta(\theta_{s+t}\omega) dt \\ & \leq e^{\frac{c}{2}s} \int_{-\infty}^0 e^{\int_{t+s}^0 (\alpha(\theta_\tau\omega) - \bar{\alpha}) d\tau - \int_s^0 (\alpha(\theta_\tau\omega) - \bar{\alpha}) d\tau - \bar{\alpha}t + s\frac{c}{2} + \log^+ \beta(\theta_{t+s}\omega)} dt \\ & \leq e^{\frac{c}{2}s} \int_{-\infty}^0 e^{-3\varepsilon(t+s) - \bar{\alpha}t + \frac{c}{2}s} dt \leq e^{\frac{c}{2}s} \int_{-\infty}^0 e^{\varepsilon t} dt. \end{aligned}$$

But the right hand side tends to zero for $s \rightarrow -\infty$.

Similarly, we obtain the convergence for $t \rightarrow +\infty$, see also Arnold [1] Proposition 4.1.3. \square

Corollary 4.7. *Suppose that f and B_j commute, i.e. it holds*

$$T(\omega)^{-1} f(T(\omega)x) = f(x), \text{ for } \omega \in \Omega, x \in H.$$

Then the conclusion of Theorem 4.4 also holds if instead of (28) we assume

$$a + L_f < 0.$$

Proof. Since the expectation of z_j^* depends on λ_j such that

$$\mathbb{E}|z_j^*| \leq \frac{1}{\sqrt{\lambda_j}},$$

we can choose λ_j sufficiently small so that $\sum_{j=1}^N b_j \lambda_j \mathbb{E}|z_j^*|$ is also arbitrarily small. \square

Remark 4.8. *Usually B_j and f commute if they are diagonal in some orthogonal basis of H (see Kwiecinska [18] and our example in Section 6).*

The commutativity assumptions for B_i ensure that (20) can be transformed into a random differential equation. However, there exist other transformations for very special classes of stochastic evolution equations to be transformed into random differential equations, see e.g. Flandoli and Lisei [11] and Mohammed et al. [21]. For the resulting random evolution equation our theory can be applied.

5. NON-LINEAR PERTURBATIONS

We now want to show that if we change the nonlinear part of (3) continuously, then the fixed points also change continuously. For this we study the family of problems indexed by $n \in \mathbb{Z}^+$ given by

$$(33) \quad dX = AX dt + f_n(X) dt + B(X) dW, \quad X(0) = u_0.$$

We suppose that the constants μ_n given by (13) corresponding to the functions f_n , satisfy $\mu_n < 0$ uniformly for $n \in \mathbb{Z}^+$. We will also denote by $\Phi_n(\cdot, 0, u_0)$, $n = 0, 1, 2, \dots$, the solution to (33), and by X_n^* their associated random fixed points. Then, our objective is to prove that the X_n^* are close to X_0^* if the f_n is close to f_0 in some sense.

Theorem 5.1. *Consider the family of stochastic evolution equations (33). Suppose that*

$$\mu := \sup_{n \in \mathbb{Z}^+} (2a + 2L_{f_n} + L_B) < 0,$$

and, in addition, that

$$\lim_{n \rightarrow \infty} f_n(u) = f_0(u), \quad \text{for } u \in H.$$

Then, for the corresponding fixed points we have

$$(L_2) \lim_{n \rightarrow \infty} X_n^* = X_0^*.$$

Proof. One can find the idea of the proof in Zeidler [26] Proposition 1.2. Denoting $\|\cdot\|_{L_2}^2 = \mathbb{E}\|\cdot\|^2$ and taking into account (12), we have

$$\begin{aligned} \|X_n^* - X_0^*\|_{L_2} &= \|\Phi_n(1, -1, X_n^*(\theta_{-1}\cdot)) - \Phi_0(1, -1, X_0^*(\theta_{-1}\cdot))\|_{L_2} \\ &= \|\Phi_n(1, 0, X_n^*) - \Phi_0(1, 0, X_0^*)\|_{L_2} \\ &\leq \|\Phi_n(1, 0, X_n^*) - \Phi_n(1, 0, X_0^*)\|_{L_2} + \|\Phi_n(1, 0, X_0^*) - \Phi_0(1, 0, X_0^*)\|_{L_2} \\ &\leq e^\mu \|X_n^* - X_0^*\|_{L_2} + \|\Phi_n(1, 0, X_0^*) - \Phi_0(1, 0, X_0^*)\|_{L_2}, \end{aligned}$$

so

$$(34) \quad \|X_n^* - X_0^*\|_{L_2} \leq \frac{1}{1 - e^\mu} \|\Phi_n(1, 0, X_0^*) - \Phi_0(1, 0, X_0^*)\|_{L_2}.$$

Now it is not hard to prove that the right hand side tends to zero. Indeed, we set $X_n(t) = \Phi_n(t, 0, X_0^*)$, $n \in \mathbb{Z}^+$, corresponding to the solution of (3) with $f = f_n$. Then by the Ito formula we obtain

$$\begin{aligned} \frac{d}{dt} \mathbb{E}\|X_n(t) - X_0(t)\|^2 &\leq \mu \mathbb{E}\|X_n(t) - X_0(t)\|^2 + \mathbb{E}\|f_n(X_0(t)) - f_0(X_0(t))\|^2 \\ \mathbb{E}\|X_n(0) - X_0(0)\|^2 &= 0. \end{aligned}$$

The inequality

$$\|f_n(X_0(t))\|^2 \leq 2 \sup_{n \in \mathbb{Z}^+} \|f_n(0)\|^2 + 2L\|X_0(t)\|^2, \quad L := \sup_{n \in \mathbb{Z}^+} L_{f_n} < \infty$$

allows us to find an integrable majorant for $\|f_n(X_0(t)) - f_0(X_0(t))\|^2$ such that pointwise convergence of $f_n(u)$ to $f_0(u)$ and the variation of constants formula yield the convergence for the right hand side of (34). \square

We now consider a family of evolution equations (20) with $f = f_n$. To obtain a family of equations of the form (26) we can apply the transformation T which is independent of n .

Theorem 5.2. *Suppose that the Lipschitz constants of f_n are uniformly bounded by L , that*

$$a + \sum_{j=1}^N b_j \lambda_j \mathbb{E}|z_j^*| + L \Pi_{j=1}^N \mathbb{E}(\|S_{B_j}(-z_j^*)\| \|S_{B_j}(z_j^*)\|) < 0,$$

and that

$$\lim_{n \rightarrow \infty} f_n(x) = f_0(x) \quad \text{for } x \in H.$$

Let X_n^* , $n \in \mathbb{Z}^+$, be the random fixed points of (20) with f_n instead of f . Then

$$\lim_{n \rightarrow \infty} X_n^*(\omega) = X_0^*(\omega), \quad \text{for } \omega \in \Omega.$$

Proof. As in the proof of Theorem 4.4 we investigate the random dynamical systems ψ_n generated by (26) with $f = f_n$ and fixed points $Y_n^*(\omega)$ attracting tempered sets, see Corollary 4.5. We have $\sup_{n \in \mathbb{N}} \|f_n(0)\| < \infty$, so, as in the proof of Theorem 4.4, there exists a tempered set $G(\omega)$ containing all fixed points $Y_n^*(\omega)$. This set is given by a ball $B(0, 2R(\omega))$ where R^2 is a stationary solution of the one-dimensional affine differential equation (30) where L_f has to be replaced by $L = \sup_{n \in \mathbb{Z}^+} L_{f_n}$ and $\|f(0)\|$ by $\sup_{n \in \mathbb{Z}^+} \|f_n(0)\|$. By the assumptions $R^2(\omega)$ exists. We have

$$\begin{aligned} \|Y_n^*(\omega) - Y_0^*(\omega)\| &= \|\psi_n(t, \theta_{-t}\omega, Y_n^*(\theta_{-t}\omega)) - \psi_0(t, \theta_{-t}\omega, Y_0^*(\theta_{-t}\omega))\| \\ &\leq \|\psi_n(t, \theta_{-t}\omega, Y_n^*(\theta_{-t}\omega)) - \psi_n(t, \theta_{-t}\omega, Y_0^*(\theta_{-t}\omega))\| \\ &\quad + \|\psi_n(t, \theta_{-t}\omega, Y_0^*(\theta_{-t}\omega)) - \psi_0(t, \theta_{-t}\omega, Y_0^*(\theta_{-t}\omega))\|. \end{aligned}$$

Since the second factor on the right hand side of (32) is independent of n if we replace L_f by L , and Y_0^* , Y_n^* are contained in the tempered ball G , we have for any $\varepsilon > 0$, $\omega \in \Omega$ and t that the first term on the right hand side is less than $\varepsilon/2$. In addition, for this t similar to the proof of Theorem 5.1 the second term on the right hand side is also less than $\varepsilon/2$ if n is large. We obtain $\|Y_n^*(\omega) - Y_0^*(\omega)\| < \varepsilon$ for large n . Since the transformation T is a homeomorphism we have the conclusion. \square

6. AN EXAMPLE

Let us take $H = L^2(\mathcal{O})$ and $V = H_0^1(\mathcal{O})$ where \mathcal{O} is a bounded domain in \mathbb{R}^d with a smooth boundary. Consider the Laplace operator $A = \Delta$ with the Dirichlet boundary condition. Theorem IX.31 in Brezis [2] ensures the existence of a sequence of real numbers $\{\nu_n\}_{n \geq 1}$ such that $0 < \nu_1 < \nu_2 < \dots < \nu_n < \dots$, and $\nu_n \rightarrow +\infty$ (namely, the eigenvalues of the Laplacian), and a sequence $\{e_n\}_{n \geq 1} \subset V \cap C^\infty(\mathcal{O})$ of associated eigenvectors (i.e. $-\Delta e_n = \nu_n e_n$ on \mathcal{O}) which is a complete orthonormal basis in H .

On the other hand, let us consider operators B_i , $i = 1, \dots, N$ such that they are diagonalizable in the same basis and are bounded from above and below (see Kwiecinska [18]), i.e., there exist constants $d_i^k, k = 1, \dots, N$ such that

$$(B_k e_i, e_j) = d_i^k \delta_{ij}, \quad k = 1, \dots, N; \quad i, j = 1, 2, \dots$$

The assumption that the operators B_k are bounded from above and below is equivalent to the condition that there exist positive constants m_k, M_k such that

$$0 < m_k \leq |d_i^k| \leq M_k, \quad k = 1, \dots, N; \quad i = 1, 2, \dots$$

Under these conditions the operators B_i generate C_0 -groups $S_{B_i}(t) = e^{B_i t}$.

Finally, consider a Lipschitz continuous function f from H into H defined as $f(u)(x) = F(u(x))$, $x \in \mathcal{O}$ with $F : \mathbb{R} \rightarrow \mathbb{R}$ Lipschitz continuous with constant L_f . Recall that $\langle Au, u \rangle \leq -\nu_1 \|u\|^2$ for all $u \in V$, and therefore the semigroup generated by A satisfies

$$\|S(t)\| \leq e^{-\nu_1 t} \quad \text{for all } t \geq 0.$$

We now study the stochastic evolution equation

$$(35) \quad dX = (AX + f(X))dt + \sum_{i=1}^N B_i X dw_i.$$

It follows that the constant μ in Theorem 3.3 satisfies

$$\mu = -2\nu_1 + 2L_f + L_B \leq -2\nu_1 + 2L_f + \sum_{i=1}^N M_i^2.$$

If $\mu < 0$, Theorem 3.3 implies the existence of a unique stationary solution to our problem which is exponentially stable in mean square. Also, thanks to Lemma 3.1 ii) and Theorem 3.5 the almost sure exponential stability of this stationary solution holds.

Observe that μ is negative only if the Lipschitz constants L_f and L_B are sufficiently small. However, by using the technique of random dynamical systems we can prove stability behaviour even for larger values of the constant L_B .

Indeed, we will be able to apply Theorem 4.4. To this end, we consider our equation (35) in its Stratonovich equivalent form

$$dX = \left[\left(A - \frac{1}{2} \sum_{i=1}^N B_i^2 \right) X + f(X) \right] dt + \sum_{i=1}^N B_i X \circ dw_i.$$

Denote $C = A - \frac{1}{2} \sum_{i=1}^N B_i^2$ which also generates a C_0 -semigroup $S_C(t)$. If the operators A, B_1, \dots, B_N commute mutually, then this semigroup $S_C(t)$ is given as

$$S_C(t) = S(t) e^{-\frac{t}{2} \sum_{i=1}^N B_i^2}.$$

Now, by easy computations (see [18]) we can deduce

$$e^{-\frac{t}{2} \sum_{i=1}^N M_i^2} \leq \|e^{-\frac{t}{2} \sum_{i=1}^N B_i^2}\| \leq e^{-\frac{t}{2} \sum_{i=1}^N m_i^2}$$

and assumption (28) in Theorem 4.4 becomes

$$\tilde{\mu} = -\nu_1 - \frac{1}{2} \sum_{i=1}^N m_i^2 + \sum_{i=1}^N M_i \lambda_i \mathbb{E}|z_i^*| + L_f \prod_{i=1}^N \mathbb{E}(\|S_{B_i}(-z_i^*)\| \|S_{B_i}(z_i^*)\|) < 0.$$

Consequently, if the operators B_i are such that $\tilde{\mu} < 0$, we can apply Theorem 4.4 and ensure that there exists a unique exponentially stable stationary solution given by a random fixed point.

Notice that this can provide better stability results than the ones obtained in Section 3. Indeed, assume for instance that $B_i u = m_i u$ where $m_i \in \mathbb{R}^+$ for i, \dots, N . This means that $m_i = M_i$, and it is easy to check that

$$\tilde{\mu} = -\nu_1 - \frac{1}{2} \sum_{i=1}^N m_i^2 + \sum_{i=1}^N m_i \lambda_i \mathbb{E}|z_i^*| + L_f,$$

since now $\|S_{B_i}(-z_i^*)\| \|S_{B_i}(z_i^*)\| = 1$. Then, if

$$-\nu_1 - \frac{1}{2} \sum_{i=1}^N m_i^2 + L_f < 0$$

(what happens if, for example, the noise intensities m_i are large enough), we can choose stationary process z_i^* corresponding to λ_i such that $\tilde{\mu} < 0$. Thus, some kind of stabilization has been obtained for the non-trivial stationary solution.
